MINUTES OF THE TWENTY-SEVENTH MEETING OF THE JOINT REPUBLICAN CONGRESSIONAL LEADERS CALLED FOR SEPTEMBER 15, 1961, at 8:30 A.M. IN THE OFFICE OF THE HOUSE MINORITY LEADER, CONGRESSMAN CHARLES A. HALLECK

In the absence of Chairman Miller, Congressman Halleck presided and called the meeting to order at 8:45 a.m.

FEED GRAIN PROGRAM

The Acting Chairman called for consideration of the first item on the agenda, the Feed Grain Program, and recognized Senator Dirksen. He read a background statement on the Administration's Feed Grain Program, and also his statement for the press conference.

There was general discussion of the Administration's handling of the Farm Problem and how the Administration's Feed Grain Program makes cheap feed grains available and results in depressed prices in the livestock, poultry and dairy industries. THREAT OF INFLATION

Congressman Halleck read a background statement reviewing the Administration's non-defense spending programs, and then read his statement for today's press conference on the Threat of Inflation in the proposed \$90 billion budget for next year.

Senator Saltonstall suggested, and Congressman Byrnes concurred, that the second paragraph relating to the Leadership's position "favoring utmost economy" should be clarified to indicate that the Leadership recognizes there has been need this session for additional National defense appropriations, and supported these appropriations. The statement was corrected accordingly and without further discussion was approved. Copy of the background statement, original and corrected copies, are attached.

OTHER LEGISLATIVE MATTERS

The possibility of passage of legislation increasing postal rates prior to adjournment was discussed, and Senator Dirksen stated the Senate will not pass postal rate increases prior to adjournment. He indicated favoring amendment of the pending House bill along the line suggested by Congresswoman St. George, to provide for a Rate Commission and escolator language tying postal employee pay raises with postal rate increases.

It was generally agreed that at today's press conference Congressman Halleck should thank the press, radio, TV, periodicals and photographers for their interest and participation in the Leadership's press conferences this year.

There being no further matters for discussion, the meeting adjourned at 9:30 a.m.
